COURT ORDER

**VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES
EFFECTIVE JULY 15, 2015**

Pursuant to 479.050, RSMo, Supreme Court Rule 37.49, the undersigned Municipal Judge of the City of Black Jack hereby orders that the following designated offenses shall be payable to the City of Black Jack Violations Bureau. In such cases, no court appearance is necessary.

This schedule is divided into four parts. Part I consists of the St. Louis County Municipal Court Uniform Traffic Violation Schedule for moving violations (points). Part II consists of the St. Louis County Municipal Court Uniform Traffic Violation Schedule for non-moving violations. Part III consists of the City of Black Jack Violation Schedule for moving and non-moving violations which are not a part of the Uniform Traffic Violation Schedule. Part IV consist of non-traffic ordinance violations which can be paid out of court as imposed the City of Black Jack.

Court Costs

In accordance with Missouri statues and ordinances adopted by the City of Black Jack, total Court Costs shall be \$23.50. This includes:


