3. Mayor Norman McCourt informed the Council that the Pickle Ball Court has been completed and ready for use.
4. Mayor McCourt also stated that the electrical wires in the park have been vandalized. The wiring to the meters was cut to the pavilions which are supplied to the comfort stations.
