The Mayor and City Council meet on the first and third Tuesday of every month at 7:00 p.m. All residents are encouraged to attend these open meetings and make their public requests. All meeting dates, times, agendas and minutes are posted on the City's web site or for additional information contact the City Clerk's office.

CITY DEPARTMENTS

The City Clerk is appointed by the Mayor and the City Council and maintains all the official records of the City, prepares and retains all meeting agendas and minutes and serves as the election official for the City.

The finance manager manages all fiscal matters concerning the City; maintains all financial records, oversees the annual budget, and monitors all revenues and expenditures of the City.

The City of Black Jack Municipal Court is the judicial branch of city government. The Court adjudicates traffic and other ordinance violations filed by the St. Louis County Police Department and City of Black Jack Code Enforcement Officer. The court clerk retains all records pertaining to the municipal court.

The inspector/code enforcement department addresses all issues, concerns and complaints regarding the upkeep of properties within the City limits. Performs all home/apartment occupancy inspections.

The Director of Public Works oversees the daily operations of the maintenance department, the maintenance of all city streets, sidewalks, public ways and municipal buildings.

The deputy court clerk/permit clerk handles all housing inspections, issuance of occupancy permits, zoning, sign, excavation and demolition permits for the City.

The City contracts with the St. Louis County Police Department for all police services for the residents of the City.



CITY GUIDELINES/SERVICES

PARKING:

- **Vehicles parked on the street between 2:00 and 6:00 am**—Parking is prohibited on all city streets between 2:00 and 6:00 am except in hardship cases whereby a permit is required. If a vehicle is going to be left on the street between these hours, a call must be placed into City Hall leaving the name, address, vehicle make and license plate number, before a ticket is issued. No more than 14 call ins per calendar quarter will be accepted. If a ticket has been issued after a call in was made, the ticket must be presented at City Hall within five days of the issuance.
- **Derelict Vehicles**—unlicensed vehicles, expired license plates, vehicles on flat tire(s) or on blocks are not allowed.
- **Parking (unpaved surface)** - All vehicles (automobiles, boats, trailers) must be parked on a paved area that is accessible from the street by means of another paved area.
- **Parking across sidewalk** - No vehicle is allowed to be parked over any sidewalk in the city.
- **No Parking on certain Cul-de-sacs.** Signs are placed on those Cul-de-sacs.

GRASS:

Grass/weeds must not exceed 7 inches or more in height. Any violations may be summoned for court action and a fine assessed.

TRASH: All trash containers must be stored **BEHIND** your building line by 9:00 pm on collection day.

ANIMALS:

All animals are required to be confined to the owner's property at all times either by leash or enclosed (fenced) area. Loud and continuous barking is prohibited; report violation(s) to Police Department or City Hall. All animals are required to have rabies vaccination through St. Louis County.

PERMITS/LICENSES:

- Required for all portable outdoor storage containers - \$25.00 fee
- Garage sale permits are required for all sales held within the City (2 per year allowed) - no fee
- Any person soliciting/peddling must obtain a permit from City Hall before commencing - \$30.00
- An occupancy permit is required for all new residents moving into the City or any additional persons moving into a present address (State ID, drivers license, and/or original birth certificates are required). Inspections must be conducted prior to the occupancy permit being issued.
- Any work being conducted on a residence may require a permit (building, electrical, plumbing, mechanical). All permits mentioned are issued by St. Louis County Public Works. For additional information, contact City Hall.
- If conducting a home business, a license must be obtained from City Hall - \$30.00 fee

NEIGHBORHOOD ASSOCIATIONS:

The City of Black Jack has various subdivisions and home associations that govern their neighborhoods. These groups have trustees that act in behalf of the residents in improving the communication between the citizens of the community and City government to help improve and resolve issues concerning their neighborhoods. VOTER REGISTRATION:
